DIRECTIONS FOR USE

These are general product recommendations:

Dilute into water at a 0.5% rate (1:200 ratio) for established crops and at a 0.25% rate (1:400 ratio) for new crop and as prevention. Use sufficient water to cover surface completely.

Thyme Guard can be used with most other chemicals or on rotation. It can also be used at any time including on harvest day.

Thyme Guard is a 100% biodegradable broad spectrum contact and systemic liquid bactericide, fungicide, virucide and insecticide for use in all crops, turf and ornamentals. It controls diseases like botrytis, late Blight, Phytophthora and Powdery Mildew just to name a few and can be applied regularly. Thyme Guard can be used as a conventional pesticide, as thyme oil repels vertebrate pests by non-toxic mode of action.
